MINUTES OF JANUARY 25, 2023

Traffic Study Hearing

The Penn Township Board of Supervisors (PTS) met on Wednesday, January 25, 2023 at 6:10 p.m. in the Municipal Building to conduct a Traffic Study Hearing. Chairman Henry A. Holman, III, Vice Chairman Karen Potteiger by phone, and Supervisor Clifford Lindgren attended. Other personnel present were Secretary Helen Klinepeter (hereinafter referred to as Secretary, and Mark O'Conner (hereinafter referred to as Solicitor). A list of visitors attending is on file in the Township Office.

Chairman Holman opened the Hearing and turned it over to the Solicitor.

Solicitor then entered Ordinance 2023-01, Ordinance 2023-02, and Ordinance 2023.03 and of the Proof of Certification and proof of posting of the Publication of the Hearing as exhibits.

Mr. O'Conner explained that Ordinance 2023-01 states the speed limit of 35 mph and penalty of violation for Faculty Road. Mr. Holman clarified that this is a portion of Faculty Road from Gambers Corner to State Road 274 (New Bloomfield Road).

Mr. O'Conner explained that Ordinance 2023-02 states the speed limit and penalty of violation for Sawmill Road. This ordinance has two portions. Section one is from Cove Road to Holman Dr with a speed limit of 40 mph.

Section two portion is from Holman Drive to Schoolhouse Road with a speed limit of 40 mph.

Mr. O'Conner explained that Ordinance 2023-03 states the speed limit of 45 mph and penalty of violation for Cove Road.

Solicitor offered that there are no visitors who wished to testify regarding these ordinances. Solicitor asked the Supervisors if they wished to talk. Supervisors declined.
