ORDINANCE 2011-01

AN ORDINANCE OF PENN TOWNSHIP, PERRY COUNTY, PENNSYLVANIA PROVIDING FOR REGULATIONS REGARDING HANDICAP PARKING SIGNAGE AND PRESCRIBING PENALTIES FOR THE VIOLATION THEREOF.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of Penn Township
'erry County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same
s follows:

- lection 1. The Township is interested in providing specialized parking for residents in Penn ownship.
- ection 2. One (1) handicap parking sign of the type prescribed by the Secretary of the ennsylvania Department of Transportation shall be erected at each location and the painting of andicap markings placed on the road at the direction as the Board of Supervisors.
- ection 3. Applicant shall provide the following information on an application presented to e Township Office.
 - a. Name, Address and Phone Number of Applicant.
 - b. Location of the desired parking space.
 - c. Proof of Handicap Parking Authorization.
- ection 4. Applicant shall pay for Handicap Parking sign and post. Township will install ndicap sign and paint markings on the street.
- ction 5. The Penn Township Police Department shall endorse the application.
- ction 6. The Penn Township Board of Supervisors shall provide final approval of the plication.
- ction 7. The operator of any vehicle parking in said handicap parking space shall display or in said vehicle a placard or other approved handicap parking designation as provided by 1.
- tion 8. The Township Police Department shall have authority to enforce the provisions of ordinance.
- rtion 9. The penalties for the violation of this Ordinance shall be in accordance with 75 CSA §3345.D.2, 3345.D.3 and 3354.E, the Motor Vehicle Code of the Commonwealth of insylvania pertaining to handicap parking and upon conviction shall pay a fine of not less lifty (\$50.00) dollars and not more than two hundred (\$200.00) dollars
