**Minutes of 12/22/25**  
**Workshop - Personnel Manual**

The Penn Township Board of Supervisors (PTS) met on Monday, December 22, 2025 at 6:00p.m. in the Municipal Building for a Workshop. Chairman Clifford Lindgren, Vice-Chairman Karen Potteiger, and Supervisor Forrest Woodward attended. Other personnel present were Solicitor (Darrell Dethlefs), Secretary Jennifer Blouch (hereinafter referred to as Secretary), Ann Delancey (hereinafter referred to as Treasurer), and Justin Hayman (Operations Coordinator). Chairman Lindgren convened the meeting with the Pledge of Allegiance and a moment of silence. The meeting was recorded to aid in the preparation of the minutes. **Personnel Manual** was reviewed.

Areas needing clarification:

Veteran status hiring preferences.

Vision and dental will be updated to state the township pays for employees but not dependents and that employees can pay for their dependent's dental/vision if motion carries at the 12/30/26 meeting.

Sick leave will be updated to allow employees to accumulate 25 days sick leave. Add that employees should get a doctor's note to use sick leave for doctor's appointments.

Add that bereavement is not a separate paid leave, but that employee can use own leave or unpaid time to take off and not be penalized.

Group weekly insurance will be changed to disability insurance.
